Setup Fees:

Database build \$2,500 Splitting a Database \$2,000

 Move locations from one database into a new one, preserving all history. See KB article "Splitting a Database" for further details.

Payroll export, first for the company

• Subsequent payroll exports are quoted as normal custom work.

EDI Feed Hourly Intacct, initial setup per "Entity" \$850

• An Intacct "Entity" can be either all the databases for a given Ctuit Partner (if they set it up this way within Intacct), or a single Ctuit client, if that client is standalone direct to Ctuit. Covers connection for either, or both, of GL or AP pushes. There's just the one time \$850 charge, once we have the entity setup for GL (or AP), if they come back later and want AP (or GL) added too, the \$850 does not apply.

Intacct, GL or AP push, per location

No locations are included in the initial setup fee, so minimum Intacct setup fees are \$1000 (\$850+at least one location)

Bill.com, initial setup per "Entity"

• A Bill.com "Entity" can be either all the databases for a given Ctuit Partner (if they set it up this way within Bill.com), or a single Ctuit client, if that client is standalone direct to Ctuit.

- reinstall assumes 'same POS', if the POS changes this is not a reinstallation, this is treated as a new install
- If a client would pay less than \$75 for a full install, we honor that lower rate for a reinstall.

Adding a location to a database, for self-installs or no install needed \$50

- Any location a client wants added so they can self-install, or if the location doesn't need an installation, incurs
 this \$50 charge
- Examples where installation isn't necessary: MDE Light Polling Location | Commissary non-poller | Corporate Office Manager Log location | any Location designated as a "no-Poll" location

Mirror & "Split (RC or Job)" Location Setups, per 10 or fraction of 10 \$200

- Please note that the target location of the Mirror or the Split has to exist in the first place, which incurs the "Adding a location" \$50 fee above. Generally a ticket is created **separately** to first add the locations, and that's where the \$50 per such location to be added fee should hit (IT knows to assign \$50 per location to that ticket).
- Setting up multiple mirrors or splits at the same time is more efficient than setting them up one at a time. If there are 8 mirrors to setup, and we get the request to add them all at the same time, then the charge is \$200 (\$200 per 10 or fraction of 10, so \$200 for 8). If, instead, the 1 mirror was requested by the client each week for 8 weeks, then the charge would be \$1,600 (8x \$200). It should be obvious that lumping the activity into as few requests as possible will save the client money.
- By "or fraction of ten", we mean 1-10 is \$200, 11-20 is \$400, 21-30 is \$600, etc.

Polling Recurring, per location:

Monthly Polling

\$99/month

- Each subsequent import of one location's file into separate discrete location(s), either within a company or into another db \$50/month
 - module recurring is full priced for such locations, not 1/2 of list. Ex: second import + GL Sales = \$65/mo (\$50 + \$15)
- "Split" Locations (Revenue Centers/Jobs) \$33/month
 - module recurring is full priced for split locations, not 1/3rd of list. Ex: split + GL Sales = \$48/mo (\$33 + \$15)
- Spreadsheet Upload only Locations \$25/month
- Non-polling Locations with Module access \$25/month
 - o locations added expressly for regular module access, like 'Corporate Office OML entries', or 'Commissary that uses Recipes'. Module recurring is full priced for these locations. Ex: Corporate Catering (non-polling) + Event Mgmt module = \$40/mo (\$25 + \$15)
- Polling an additional device \$5/month
 - o (ex: QSR | WMx | "Standard Timekeeping Format")
- Intraday Polling, 1 to 14 addt'l polls +\$1/mo per addt'l poll
- Intraday Pollng, 15+ addt'l polls \$15/mo
 Test or Bench Locations \$0/month
 - It's intended that these locations transmit only intermittently, and don't have Module access granted

• ERD access is per "entity", not per database. So a Partner like AMP Services pays \$250 per month, no matter how many client databases they have. Craftworks pays \$250 per month, for both their databases (CWBRG and OC).

Partner Transitions:

If client leaves a Partner and comes directly to us:

\$1,500 Training Fee

Module setup fees as applicable and per standard pricing; i.e. new GL Sales COA \$500, AP \$500, Payroll \$500, etc. May have to ask some questions upfront to determine correct pricing for order form

If client leaves a Partner and goes to another Partner –OR- the client leaves Ctuit direct for a Partner:

\$0 Training Fee

Module setup fees as applicable and per standard pricing, this may apply even if the module is already on, if extensive changes are necessary to the module for the Partner's setup.

• ex: GL Sales module, if the request is to purge out the current COA and rebuild the COA and Rules with the Partner's COA, then the GL Sales Setup fee would apply

Other:

Custom programming

\$200/hour

- Reports, Exports, Widgets, Key Info metrics, minor Integrations work
- EDI and EPO builds
- Renumbering a location
- Historical data upload, from spreadsheet
- Non-COGS time bank related data repair
- Requests to add a 'definition' to the database, such as Susie Cakes and their comp additions, or Metz and their sale department additions

Training and Implementation assistance \$150/hour ERD support \$200/hour

Historical data upload, from POS \$.50/per location day recovered

Our minimum time billed is half an hour.
